Thank you for your email on 10 September 2021 requesting the following information under the Official Information Act 1982 (OIA):

- 1) *From 1 January to 30 June 2021, how many OIA requests did your agency receive?*
- 2) *From 1 January to 30 June 2021, what was the average OIA response time (including any extension time)?*
- 3) *From 1 January to 30 June 2021, what was the longest OIA response time (including any extension time)?*
- 4) *From 1 January to 30 June 2021, what percentage of OIAs required a time extension?*
- 5) *From 1 January to 30 June 2021, what percentage of OIAs were refused?*
- 6) *From 1 January to 30 June 2021, what percentage of OIAs were partially refused or redacted?*

Te Tūāpapa Kura Kāinga – Ministry of Housing and Urban Development (the Ministry) has completed 73 OIAs between 1 January 2021 and 30 June 2021.

The Ministry does not report on OIA response times. However, we have attached an anonymised spreadsheet which shows each OIA completed between 1 January and 30 June 2021 with the date it was received, the legislated due date, the date the response was sent, and whether it was extended.

The Ministry does not record the number of OIAs that were refused, that were partially refused, and/or had redactions applied. This part of your request is refused under section 18(e), that the information requested does not exist.

It may interest you to know that all government agencies report bi-annually the number of OIA responses they complete to Te Kawa Mataaho Public Service Commission. This reporting also includes the number of responses completed within the statutory timeframe, the number of responses published, and the number of complaints made to the Ombudsman.
