The sessions were well attended, and there were useful discussions that focused on what costs councils may recover under development levies, high-cost levy zones, out-of-sequence and unplanned development, charging and collection arrangements, and transition arrangements.</li></ul>

## Better social housing and housing supports: Policy

### **CURRENT STATUS**

#### *Funding, financing and regulatory settings*

- On 3 March 2025 Minister Bishop received a briefing seeking agreement to changes to the process for providing upfront operating supplement to CHPs [HUD2025-006163 refers].
- HUD is also supporting Treasury in the development of a liquidity facility and CHP loan guarantee scheme.

#### *emergency and temporary housing*

- HUD and MSD are working with Minister Potaka on next steps in relation to Government Target 8 – Reducing EH. This includes an update of the EH target delivery plan to reflect the need to maintain current progress.
- The DPMC Delivery Unit is developing advice for the Prime Minister on approach where a target has been achieved.

### **RECENT DECISIONS MADE**

#### *Funding, financing and regulatory settings*

- On 26 February 2025 Minister Bishop agreed to the Crown providing loans or guarantees to a private lender, through complementary approaches of offering a liquidity facility to the Community Housing Finance Agency and exploring a loan guarantee scheme for bank lending to CHPs [T2025/259 refers].

#### *Purchasing function (housing funding authority) and approach*

- On 17 February 2025, Minister Bishop agreed that HUD should progress the functions expected of a housing funding authority through its Delivery group and stand up an independent advisory group.
- Minister Bishop also agreed that HUD will progress enhanced data sharing arrangements and report back on options for changes to delegations enabling arms-length decision making.

## UPCOMING DECISIONS AND MILESTONES

### *Funding, financing and regulatory settings*

- On 6 March 2025, Minister Bishop will receive advice and a draft Cabinet paper from Treasury on the liquidity facility for the Community Housing Finance Agency and recommended key design features of a CHP loan guarantee scheme for banks
- Subject to Minister Bishop's agreement, HUD will work to communicate and implement the new process and criteria for approving upfront OS to CHPs.

Within the next two weeks HUD intends to sign letters of intent with each of the Partners to confirm how many social houses places we agree they will endeavour to deliver by June 2027 and to give them and their financiers confidence to progress projects while formal contracting is completed (by the end of May).</li><li>To date, we have received proposals from two Partners identifying firm proposals for initial projects that will deliver 178 places.</li><li>s 9(2)(f)(iv)</li></ul>								
<i>New investment approach</i>
