Dear s 9(2)(a)

Thank you for your email dated 3 May 2021 requesting the following information under the Official Information Act 1982 (the Act):

- *All project funding applications received by MHUD or its predecessor agencies in the period November 2017 to the present day from approved public housing partners, including all applications made using the "Application for Funding Gateway" form set out on the MHUD website.*
- *For each application I request information about whether MHUD and or the Minister of Housing decided to allocate funding to the project and in each instance how much funding was allocated, the form that funding took (whether operating supplement, upfront funding or a combination of the two) and how many houses were expected to be delivered as a result of this funding.*

The table in Annex 1 shows the number of public housing applications received per month between November 2017 and May 2021 listed by Community Housing Provider and the outcome of the application, the form that funding took, and how many houses were expected to be delivered as result of this funding.

The Housing Supply Team at Te Tūāpapa Kura Kāinga – Ministry of Housing and Urban Development (the Ministry) works closely with providers to review and provide feedback on potential opportunities. Providers generally submit applications once proposals are well developed. The time from when an application for funding is received to when the project is delivered varies depending on the complexity and scale of the project.

Applications that are still in progress have been withheld under section 9(2)(i) of the Act, to enable a Minister of the Crown or any department or organisation holding the information to carry out, without prejudice or disadvantage, commercial activities.

The amount of funding allocated per application has also been withheld under section 9(2)(i), and 9(2)(ba)(i) to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied.

The Ministry was established on 1 October 2018 and brought together the functions from the Ministry of Social Development and the Ministry of Business, Innovation and Employment; along with the monitoring of Housing New Zealand and Tāmaki Redevelopment Company from The Treasury. Applications that were received before the Ministry's establishment are unable to be listed by month as we do not have a record of the specific date they were received.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the decision to withhold information under section 9 of the Act is not outweighed by other considerations that render it desirable to make the information available in the public interest. You have the right to seek an investigation and review of my response by the Ombudsman, in accordance with section 28(3) of the Act. The relevant details can be found on the Ombudsman's website www.ombudsman.parliament.nz.

As part of our ongoing commitment to openness and transparency, the Ministry proactively releases information and documents that may be of interest to the public. As such, this response, with your personal details removed, may be published on our website.
