Thank you for your email of 13 June 2023 requesting the following information under the Official Information Act 1982 (the Act):

I am requesting information related to contracts held with Kahungunu Whānau Services and correspondence with both the organisation's board and former chief executive Ali Hamlin-Paenga.

- *All emails between department staff and Ali Hamlin-Paenga from January 1 2020 until May 31 2023*
- *All emails between department staff and board members of KWS including Peggy Luke Ngaheke from January 1 2020 until May 31 2023 – particularly if they relate to Ali Hamlin-Paenga and personal relationships between MHUD and KWS.*

On 15 June 2023 you refined your request to:

all emails sent or received by Te Tūāpapa Kura Kāinga - Ministry of Housing and Urban Development and Ali Hamlin-Paenga, Peggy Luke Ngaheke or Kahungunu Whānau Services board members regarding management of the relationship between the two parties.

One email has been found to be within scope of your request and is released to you with mobile phone numbers withheld under section 9(2)(a) of the Act, to protect the privacy of natural persons.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the decision to withhold information under section 9 of the Act is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review of my response by the Ombudsman, in accordance with section 28(3) of the Act. The relevant details can be found on the Ombudsman's website at: www.ombudsman.parliament.nz.

As part of our ongoing commitment to openness and transparency, the Ministry proactively releases information and documents that may be of interest to the public. As such, this response, with your personal details removed, may be published on our website.

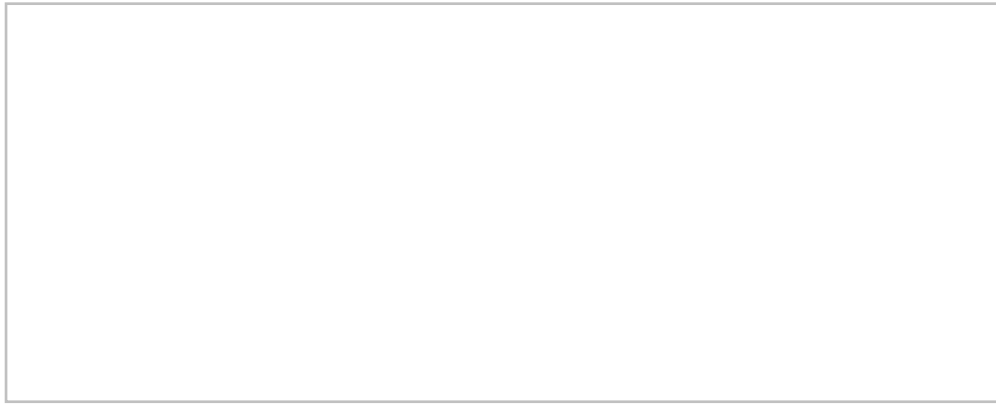
