### Increasing rental supply

The Minister of Housing will receive a draft Cabinet paper on Tuesday 2 November to circulate to colleagues for feedback by 8 November. Te Tūāpapa Kura Kāinga will provide the Minister of Housing with a final draft Cabinet paper on 10 November, so it can be lodged for consideration at the Cabinet Economic Development Committee meeting on 17 November 2021.

### First Home Products

Te Tūāpapa Kura Kāinga is seeking Minister Woods' and Minister Henare's feedback on the draft Cabinet Economic Development Committee paper - Modernising First Home Products -

### Kāinga Ora Land Programme

We have updated the draft letter from the Minister of Housing to the Chair of Kāinga Ora, and provided a copy to her office. The updated draft reflects the Minister's feedback on the original, draft that was attached to Te Tūāpapa Kura Kāinga briefing BRF20/21071040: Kāinga Ora Land Programme: performance expectations and reporting.

#### Land for Housing

Land for Housing Programme will have under \$100 million left for acquisitions once the current set of briefings with Ministers are signed. At the same time, discussions regarding several parcels of land are coming into their final stages in the fourth quarter of 2021. This includes but is not limited to – \$9(2)(f)(iv) land owned by Radio New Zealand at Titahi Bay with Ngāti Toa, and (in partnership with the 13 iwi/hapū that are the Tāmaki Collective / Ngā Mana Whenua o Tamaki Makaurau) Epsom College and the former Auckland Central Police Station. In order to proceed with these land acquisitions, the Programme will be seeking Cabinet agreement as early as possible in 2022, to a fiscally neutral transfer of funds from the KiwiBuild appropriation as signposted in the October Baseline Update.

### Converted facility Wellington

Te Tūāpapa Kura Kāinga is seeking Minister Woods' comfort with progressing a converted facility opportunity in Wellington to address short term housing needs for singles and couples currently accommodated in COVID-19 motels or emergency housing.

This proposed facility would provide 26 places (mainly studio units) in Wellington (Te Aro). If Minister Woods is comfortable with progressing, subject to successful due diligence and negotiation, the property would be expected to be available to tenant by April 2022.


