Decision/direction sought

Oral update on the implementation of the welfare and accommodation responses under the COVID Protection Framework (CPF)

- In response to the December 2021 Cabinet paper on the implementation of the welfare and accommodation responses under the CPF, Cabinet invited the Minister of Housing and Minister for Social Development and Employment to provide an oral update on implementation in February 2022.
- The decision to provide an oral update was made in the context of a Delta outbreak, at which time
 there was little known about an Omicron outbreak. Given the changing environment we
 recommend cancelling the oral update. Subject to your agreement to the recommendation to
 cancel this, your office will contact the Cabinet Office to confirm.
- Te Tūāpapa Kura Kāinga will continue to work with other agencies to plan for the Alternative Isolation Accommodation service, including any input required into the March report back to Cabinet on Care in the Community, led by the Ministry of Health.
