Unit Titles Act 2010 – amendments to Member's Bill

- Te Tūāpapa Kura Kāinga provided Minister Williams with a draft Cabinet paper on the Unit Titles (Strengthening Body Corporate Governance and Other Matters) Amendment Bill on 22 July. Officials request feedback by 3 August, in order to finalise the Cabinet paper for lodgement with Cabinet Office on 5 August.

Māori Housing WAI 2750	<p>WAI 2750</p> <ul style="list-style-type: none"> The most recent hearings for Wai 2750 concluded on 25 June, where Crown witnesses presented evidence on housing policies and services, and were cross-examined by claimant counsel and the Tribunal. During the hearings, two key matters arose: <ul style="list-style-type: none"> There is uncertainty of the timing and approach for Crown and claimant counsel to make closing submissions; and Crown counsel confirmed that the Crown is currently considering the implications of the finding in the <i>Oranga Tamariki Urgent Inquiry</i> report that there is a 'guarantee of tino rangatiratanga over kāinga'. On 28 July, the Tribunal issued directions for timing and approach for Crown and claimant counsel to make closing submissions. Hearings for these will take place for the claimant counsel, in September, and for the Crown, in November. The Tribunal also directed the Crown to file its position on its Treaty duties in housing in August. Meanwhile, research briefs have been proposed for 6 topics to complete the case book. We will advise Ministers Woods and Henare, as co-lead Ministers for Wai 2750, further on the following: <ul style="list-style-type: none"> Tribunal directions on the timing and approach for making closing submissions, and the appropriate approach the Crown must take along the ARA in presenting its closing submissions (that will take place in November); The Crown's approach to developing its position on its Treaty obligations, taking into account the finding of the <i>Oranga Tamariki Urgent Inquiry</i> report. We will commission research into Māori housing 1840-1934.
