Unit Titles Act 2010 - amendments to Member's Bill

Te Tūāpapa Kura Kāinga provided Minister Williams with advice on proposed amendments to the
disclosure regime in the Member's Bill on 21 June, with feedback requested by 29 June. Officials
also provided Minister Williams with proposed amendments to the body corporate managers
regime in the Member's Bill on 24 June, with feedback requested by 1 July.

Māori Housing WAI 2750	 Wai 2750 Hearing week 3 for Crown evidence was last week. Evidence from Te Tūāpapa Kura Kāinga, MSD, Kāinga Ora, Te Puna Kōkiri and Ara Poutama was presented. Counsel for the Crown led with opening submissions that included the Crown's acknowledgements and concessions for Stage One of the Inquiry. Questioning from claimant counsel and the Tribunal explored the relationship between Crown and Māori around housing and in particular Māori homelessness. Minister Woods and Minister Henare have reactive messages provided in AMI20/21050521 should any of the issues raised in the hearing week require a response from both Ministers. 	An Aide-memoire detailing the cross-examination, questions from the panel and discussion will be provided.
	 Māori Housing Strategy The Project Oversight Group and Working Group have continued to meet regularly to progress work to develop the new Māori Housing Strategy. A series of regional engagements were conducted in person with Māori organisations and housing providers in six locations (Kerikeri, Auckland, Hastings, Wellington, Christchurch and Gisborne) by Te Tūāpapa Kura Kāinga, Te Puni Kōkiri and Te Matapihi from 21 – 26 June. 	Following initial engagement, the Strategy will be discussed at the second Te MAIHI Whare Wānanga, to be held in Wellington on 8 July 2021.

Local Innovation and Partnership Fund Following recent advice to Minister Davidson, Te Tūāpapa Kura Kāinga is preparing for Round 2 of the Fund which will include significant process improvements and enhancements and retention of a portion of the Fund to be distributed in 2022. 	 Implementing the National Policy Statement on Urban Development (NPS-UD) Following consultation in late 2020, Wellington City Council's revised draft Spatial Plan has been reported back to its Planning and Environment Committee. When finalised, the Spatial Plan will set out where the city is expected to grow and develop over the next 30 years. Although the Spatial Plan is non-statutory, the proposed zoning can expect to be incorporated into the District Plan. This will occur as part of the changes Wellington City Council needs to make to implement the NPS-UD. These changes are due to be notified in August 2022. In the revised draft Spatial Plan, council staff have attempted to comply with the requirements of the NPS-UD. This has resulted in simpler zoning that is highly enabling in the centre city and reasonably enabling in inner city suburbs and within walkable distances of rapid transport stops. The revised draft also outlines where the council thinks there should be character precincts. In some cases, these proposed character precincts cover a significant area and 	There will be further opportunities for the council to consider the overall zoning and the scope of the character precincts, both as the Spatial Plan is finalised and as it is incorporated into the draft district plan change. Te Tūāpapa Kura Kāinga will continue to work with the council as it does so.
